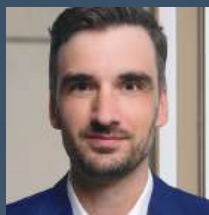

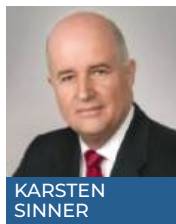

Private Debt vs. Bank Loans: A Game of Leverage and Limits

Banks continue to finance the majority of the European market's needs—a stark contrast to the U.S., where private capital dominates. Yet private debt is gaining ground, driven by the evolving financing demands of the energy and infrastructure transition. Multi-sourced structures—blending bank facilities with institutional term loans—are becoming the norm. For debt investors and lenders, this shift opens up opportunities across the spectrum, from large-scale deals to the lower mid-market. As liquidity remains critical, the question persists: does current pricing adequately reflect underlying risk—and where can attractive returns still be found?
